- e. guarantee the efficiency, reliability and safety of the machines, equipment, infrastructures and plants used, both considering the technological opportunities available at the time of purchase and guaranteeing the appropriate control and maintenance measures;
- f. to obtain maximum collaboration from personnel in optimising and improving performance through communication, information, consultation, participation, training and surveillance activities;
- g. promote collaboration and cooperation with its suppliers of products, activities and services in order to ensure final customer satisfaction, respect for the environment and health & safety through evaluation, selection, communication, information and surveillance procedures;
- managing possible accidents, injuries, occupational diseases, emergencies and non-conformities, through the investigation and analysis of the causes and the implementation of actions of intervention, mitigation, correction and prevention;
- i. adopt appropriate evaluation and monitoring systems for the Integrated Management System to ensure its effectiveness and continuous improvement.
